

City of Llano Regular Called City Council Minutes December 4, 2017 – 5:30 p.m.

A. <u>CALL TO ORDER</u> —Mayor Lang called the meeting to order at 5:30 p.m. with the following present: Mayor Pro-Tem Leverett, Alderman Miiller, Alderwoman Stephenson, Alderman Bauman, and Alderwoman Tudyk.

F. PUBLIC HEARING

1. Public hearing to be held Monday, December 4, 2017 to receive written and/or oral comments regarding the request to consider closing, vacating, abandoning, and conveying an unimproved portion of Cedar Street and the alley behind 800 E Green. This street is a portion of the Oatman addition next to Block 36 Lots 1 & 2. The physical location of this street closure request is located on the unimproved portion of Cedar St. bordered by E Green to the North, E College to the South, Oak St to the

West and Ash to the East. The physical location of the property is adjacent to 800 E Green.

Mayor Lang opened the public hearing at 5:35 p.m. to receive written and/or oral comments regarding the street/alley closure. Applicant Gerald Lowery spoke and pointed out where the closure request would be on Cedar Street and in the alleyway. He spoke regarding the utilities and during the public comment portion of the public hearing, asked if Council would consider waiving the fees. Mayor Lang advised Mr. Lowery, the waiving of the fees was not on the agenda and could not be discussed, but suggested Mr. Lowery make his request at the next Council meeting. Hearing no other public comments, Mayor Lang closed the public hearing at 5:42 p.m.
