

RESOLUTION NO. R- 2019-02

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LLANO, LLANO COUNTY, TEXAS, ORDERING THE GENERAL AND SPECIAL ELECTIONS TO BE HELD JOINTLY WITH THE LLANO INDEPENDENT SCHOOL DISTRICT AND ADMINISTERED BY THE LLANO COUNTY ELECTIONS ADMINISTRATOR ON MAY 4, 2019, FOR THE PURPOSE OF ELECTING A MAYOR AND TWO (2) COUNCIL MEMBERS, TO THE LLANO CITY COUNCIL TO HOLD OFFICE FOR A PERIOD OF TWO YEARS; AND FOR THE PURPOSE OF ELECTING A COUNCIL MEMBER, TO THE CITY OF LLANO CITY COUNCIL, FILLING AN UNEXPIRED TERM, TO HOLD OFFICE FOR A PERIOD OF ONE YEAR; DESIGNATING LOCATIONS OF POLLING PLACES; DESIGNATING FILING DEADLINES; PROVIDING FOR A RUNOFF ELECTION; ORDERING NOTICES OF ELECTION TO BE GIVEN AS PRESCRIBED BY LAW.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LLANO, TEXAS, THAT:

SECTION 1: Elections are hereby ordered to be held jointly with the Llano Independent School District on May 4, 2019, for the purpose of electing a Mayor and two (2) City Council Members, to fill the expiring terms on the Llano City Council; And for the purpose of electing a City Council Member, to fill the unexpired term on the Llano City Council.

SECTION 2: The Election Day polling place where qualified voters shall cast ballots at such location in the City of Llano, 2019 General Municipal Elections are as follows:

SECTION 3: Early voting for this General Election shall be conducted by the Llano County Elections Administrator. Applications for early voting by mail shall be requested from and mailed to the Early Voting Clerk at the following address:

Applications for ballot by mail must be received no later than the close of business on April 23, 2019.

SECTION 4: Candidates must file for a specific place and adhere to the filing deadlines accordingly. Candidate Packets are available in the City Secretary's Office. The candidate filing periods for the General Election for Mayor and Places 4 and 6 begins on January 16, 2019 at 8:00 a.m. and ends February 15, 2019 at 5:00 p.m. The candidate filing periods for the Special Election begins on January 16, 2019 and ends March 4, 2019 at 5:00 p.m. Candidates must file in the City Secretary's Office located at 301 W Main St., Llano, TX

SECTION 5: If two or more candidates for the office of Mayor or Council Member tie for the number of votes required to be elected, the tie shall be broken in accordance with the Texas Election Code, including Chapter 2 thereof.

SECTION 6: The City Secretary is hereby authorized and directed to publish and/or post, in the time and manner prescribed by law, all notices required to be so published and/or posted in connection with the conduct of this election. The Rockwall County Election Administrator, in accordance with the contracts, shall designate the election judges for the joint election. The election, including providing the notice of the election, shall be conducted in accordance with the Texas Election Code and other applicable law, and all resident qualified and registered voters of the City shall be eligible to vote at the election.

SECTION 7: The Mayor is hereby authorized to execute Contracts for Election Services between the Llano County Elections Administrator, Llano Independent School District, and the City of Llano, attached as Exhibit "A" and Exhibit "B" respectively.

SECTION 8: The Mayor and the City Secretary of the City, in consultation with the City Attorney, are hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Texas Election Code and any other state or federal law in carrying out and conducting the election, whether or not expressly authorized herein.


