

RESOLUTION NO. 2013-04-15-1

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LLANO, TEXAS;
ESTABLISHING RATES FOR THE USE OF THE LLANO MUNICIPAL AIRPORT HANGARS;
AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS: The Mayor and City Council of the City of Llano realize the Llano Municipal Airport provides an invaluable service to the citizens and visitors to the community; and

WHEREAS: The Mayor and City Council of the City of Llano have taken steps to improve the Llano Municipal Airport by having had constructed new hangers for the storage airplanes and aeronautic related materials as set forth in the Hanger Lease Agreements; and

WHEREAS: The Mayor and City Council of the City of Llano have requested and received recommendation from the Airport Advisory Committee of the Llano Municipal Airport to establish rates and fees for use of the Llano Municipal Airport Hangers; and

WHEREAS: The Mayor and City Council of the City of Llano have reviewed the recommendation on the establishment of rates and fees for use of the Llano Municipal Airport Hangers.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LLANO, TEXAS THAT:

SECTION 1.

A. Monthly Fees for each number hangar unit after the passage of this resolution shall be:

B. Monthly Fees for each newly constructed hangar unit after the passage of this resolution shall be:

42 X 34 Box Hangers	\$250.00 per month	Limit of One Plane per Hanger
50X34 Hanger	\$300.00 per month	For one plane with an additional charge of \$50.00 per month for the second plane. Additional charge is to be on an annual basis.

75X75 Hanger

\$1,000.00 per month

C. The current monthly discount shall be allowed of 10% and shall remain with the current contracts. Any contract entered into from the passage of this resolution shall not have the monthly discount included.

SECTION 2. This RESOLUTION shall become effective from and after its passage and publication as required by law.
