

ORDINANCE 1382 -2

AN ORDINANCE OF THE CITY OF LLANO, TEXAS, AMENDING ORDINANCE NUMBER 1359 CONCERNING THE BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2018 PROVIDING FOR VARIOUS UNFORESEEN EXPENDITURES.

WHEREAS, the City Council of the City of Llano, Texas finds these expenditures to be in the best interest of the public health, safety and welfare; and

WHEREAS, these expenditures meet unforeseen conditions, which could not, by reasonable diligent thought and attention have been included in the fiscal year 2017-2018 budget; and

NOW THEREFORE BE IT ORDAINED:

The General Fund is amended as follows:

Revenues:

Revenues in the amount of \$1,000 are added for private donations made to purchase barrel racing lasers for the John L. Kuykendall Arena.

Expenses:

John L. Kuykendall Events Center
Department 606

Expenses in the amount of \$1,000 are added for purchasing barrel racing lasers. The JLK Events Center budget now totals \$182,529.

LanTex
Department 610

Expenses in the amount of \$1,400 are added to extend the warranty for the audio/video system server. The LanTex budget now totals \$27,250.

ORDINANCE 1383

AN ORDINANCE OF THE CITY OF LLANO, TEXAS, MAKING APPROPRIATIONS FOR THE SUPPORT OF CITY SERVICES FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018, AND ENDING SEPTEMBER 30, 2019 APPROPRIATING MONEY TO A SINKING FUND TO PAY PRINCIPAL AND INTEREST ON THE CITY'S INDEBTEDNESS; AND ADOPTING THE ANNUAL BUDGET OF THE CITY OF LLANO, TEXAS, FOR THE 2018-2019 FISCAL YEAR.

WHEREAS, the annual city budget, appended hereto as Exhibit A, for the fiscal year beginning October 1, 2018 and ending September 30, 2019, was duly presented to the City Council by the City Manager, and a public hearing was ordered, a public notice of said hearing was caused to be given, said notice was published in the Llano News, and said public hearing was held according to such notice:

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Llano, Texas:

SECTION 1. That the appropriations for the support of the general government of the City of Llano, Texas, be fixed and determined for said terms in accordance with the expenditures shown in the city's fiscal year 2018-2019 budget, a copy of which is appended hereto as Exhibit A.

SECTION 2. That the budget as shown in words and figures in Exhibit A is hereby approved in all respects and adopted as the city's budget for the fiscal year of 2018-2019.

SECTION 3. That there is hereby appropriated the amount shown in said budget necessary to provide for a sinking fund for the payment of the principal and interest of the indebtedness of the City.
