- CONSTRUCTION DEBRIS FROM REMODELING, REPAIR OR DEMOLITION OPERATIONS
- PLASTICS, GLASS
- WOOD, LUMBER
- ROOFING SHINGLES, GRAVEL, SHEET METAL
- SHEET ROCK
- BULKY ITEMS, SINKS, TUBS, SHOWERS
- FLOORING, TILE, CARPET
